

The History

The Syracuse Fire Department Credit Union is a non-profit organization that began over 60 years ago, to help Syracuse Firefighters in need of financial assistance. The funds came from the members themselves, and the Credit Union has grown greatly and now offers many financial services to its members.

The Award

The Credit Union is proud to facilitate several scholarship programs. A scholarship program outline is attached defining the different scholarships available as well as the award amount and the specific criteria that needs to be met to be eligible. The completed applications will also be forwarded to the Credit Union Association of New York and be eligible for their scholarship awards in the amount of either \$1,000 or \$500. Awards will be deposited directly to the students credit union account upon receipt of college acceptance letter.

Eligibility

The applicant must be a member in good standing and meet all of the criteria outlined below.

Application Process

To apply, eligible members must complete this scholarship application form. Applicants should type or print clearly and use only the space provided on this form to answer the questions. Other than specified below, no attachments, resumes, pictures or other material of any kind should be used to answer the questions or should be submitted.

1. The signed application must be submitted together with:
 - _____ An official high school transcript documenting student's GPA for grades 9-11
 - _____ An SAT/PSAT/ACT transcript (obtained through the high school guidance office)
 - _____ A typed essay response
 - _____ A picture of the applicant (to be used in the event of being awarded a scholarship. Pictures can be emailed directly to tonia@syrfirecu.com)
2. The applicant and his/her parents/guardian must sign the Certification and Release Authorization on the back page of this form.
3. The application, transcripts, and essay must be returned to the credit union by January 4, 2019. If any portion is incomplete or not included, the application will not be considered.

Selection Process

Judging will be based on both subjective criteria and weighted, objective criteria. These include academic achievements, extracurricular and community activities, the essay, etc. Applications are sent to judges who are not directly affiliated with the credit union. All personal information such as names and addresses are blocked to keep the identity of the applicant private from judges and the ensure judging is unbiased.

Application Deadline

Applications must be returned to the credit union no later than Friday, January 10, 2020.

- If you ran your credit union, what is one new initiative/program you would implement?
